Vision Statement for the Central New York Chapter New York Forest Owners Association By Dan Zimmerman

I would like to extend a hello to the membership of the Central New York Chapter of the New York Forest Owners Association. (NYFOA). I am honored to be your new chair. I would like to thank Ralph Meyer for the work and leadership that he has given this organization. Great work, Ralph! I hope Ralph stays on as a consultant and participant into the foreseeable future.

Collaboration, organizational structure, and volunteerism/participation are the topics I would like to discuss briefly. There are many exciting endeavors that could be undertaken. Core beliefs of NYFOA as stated on the web site are:

- Promoting science based resources to support woodland stewardship.
- Supporting woodland owners in the long-term stewardship of their forest resources.
- Raising public awareness of the challenges to sustaining our forests.
- Seeking collaborations with other organizations having similar goals and objectives.
- Respecting private property rights as they relate to sustainable forest stewardship

Collaboration can be defined as working with people and/or organizations to produce a desired end result. I see great possibilities in working with other organizations and groups of people! The forest community consists of many interests, some of which could be our partners. Unbelievably (at least to me), is the exclusion, and sometimes vilification, of some sectors of the forest community that are actually crucial to forest management. Having worked in the forest for close to forty years I've seen a lot and would point out that in every group of people and professions there are good and bad, honest and dishonest. Casting a whole group of people (timber harvesters for example) in a negative way imparts a poor public opinion not only of harvesters, but also of our organization! I would like to collaborate with this sector and others to better organizational effectiveness and viability. There are some really great people to be found here and elsewhere in the "forest community".

Additionally, I would like to envision a more cosmopolitan chapter that receives support, opinions, and input from varied but related organizations. Having largely one benefactor can result in a lack of diversity in thought, practice, and support for our members.

It is my hope that we can make an exceptional chapter operating under our core beliefs that would serve as an example of collaboration for the entire state! To that end I would like to propose the creation of two committees:

- 1. One centered on event planning: walks, dinners, and educational endeavors.
- 2. Another centered on awards to outstanding forest owners and recommendations for increasing membership and their implementation.

We have some exceptional members who would be a huge asset and their input would greatly help us all with the infusion of ideas and participation. The mechanism of organizational structure would enhance and free up leadership to address other concerns.

So, how about it? Can you volunteer some of your time to committee work? If I don't hear from you, I'll be calling! Of all the ideas expressed in this writing, I feel the most important is volunteering and participation by the present membership. It is my surmise that we have some outstanding members who by participation, utilizing acquired life skills, and contacts, can ultimately be responsible for a truly vibrant and unique chapter!
