COMING NYFOA PROGRAMS

WOODSWALK, CUYLER HILL STATE FOREST, SATURDAY, MAY 22ND

Here is a rare opportunity to learn from the master. Our woodswalk will be led by Dr. Ralph Nyland, Distinguished Service Professor from Syracuse University's College of Environmental Science and Forestry. Dr.Nyland is widely published and is the author of the acclaimed book "Silviculture – Concepts and Applications". He has also developed and overseen timber stand improvement projects in several stands within the Cuyler Hill Forest. DEC State Forester Mark Zubal will accompany us on the woodswalk, and will discuss salvage harvesting in several stands decimated by the Forest Tent Caterpillar.

The woodswalk will begin at 9:30 and finish at approximately 12:30. Please call or Email Jerry Michael by May 15th if you plan to attend. We will cancel the event and call you if there is insufficient signup, or if severe weather is forecast.

Directions: Cuyler Hill State Forest is in the NE corner of Cortland County. From the south, take Rt. 26 N through Cincinnatus. Turn left on County Rd. #12 (Lincklaen Rd.) & go 7 mi. Turn left on Randall Hill Rd. in Lincklaen and go 1.4 miles. It is a dirt road after the first half mile. We will assemble at the first intersection (look for NYFOA sign). Anyone interested in car-pooling from Cornell Cooperative Extension in Broome County should assemble in the rear parking lot by 8:00 a.m.

The Level One course includes the basics of chainsaw safety, saw maintenance and directional felling techniques. Each participant will drop at least one tree under Bill's supervision. Bill will also demonstrate the use of ATV logging equipment. The cost of this all-day course is \$132 for NYFOA members (subsidized by the Chapter) and \$152 for non-members. JUSTIFYING OUR WOODLAND TOYS

(Editor's note: The following article was written by Bob Coupal, Editor for the NYFOA Northern Adirondack Chapter Newsletter. I thought it was a helpful testimonial and would be of interest to some of our members. Questions can be directed to Bob at bob@gompc.net.)

"Even though it took over 50 years, we finally broke down and bought a tractor last year for our 240 acres of forestland. For three generations we have used shovels, scythe's and sheer will to manage our forest. Although we did replace the hand ax with a chain saw a long time ago, the brute work was still done by hand (or back). The addition of an ATV and then subsequently a UTV was a huge step in efficiency, as we no longer had to carry chain saw, fuel and other supplies to every forestry task.

Once we decided to commit to a tractor (compact = forest trail size) it opened up a whole new level of efficiency and safety. Our 6 miles of ATV width trails can now be cut in one pass and our meadows can be brush hogged in fall after bird nesting season. All in a day vs. a full week of hand held bush blading. One of our concerns was forest impact. We already use logging arches with either an ATV or UTV to remove wood from the forest in a linear path but wanted a tractor to be nimble, but hefty enough to dig and lift when needed. Initially we thought the subcompact size would be best (nimble) but quickly realized the standard compact would be the minimum size due to the heft needed. We chose the Kubota B2630. What amazed us with all the current tractor capabilities regardless of brand is how easily and precise they are to control. JT, our 9 year old, used the mid mount mower right off the delivery trailer that day, cutting one of our easy flat grass roads with confidence.

Then less than 6 months after taking delivery of the tractor, our shallow water line froze from the wellhead to the cabin. Good time to test the backhoe. Wife Sally and JT both pitched in taking turns digging a 4'+ deep trench across our yard and it was nearly effortless. No wasting days of precious vacation time, no organizing rental equipment to be delivered and most importantly no back ache.

There is one implement in particular that we "hemmed and hawed" about, but took our dealer's advice when he said, "once you put the ANBO Grapple on you may not ever take it off". This is a wonderful forest tool. I only wish we had it for the ice storm cleanup. The precise handling of the jaws allows you to pick up a 2x6 that is sitting flat on the ground, and has heft enough to lift and place a 8' long Black cherry log that is 24" in diameter on to our band saw mill. You can even drive the lower jaw in to the ground to remove undesirable vegetation or to lift and replant conifers or saplings in another location. We've even used the top jaws while going in reverse to lightly scarify areas in our meadow for some reseeding. Sure enough the front-end loader rests under the tarp! No wonder JT appropriately nicknamed the tractor "Obi Wan Kubota". The force is definitely with us now."

Directions to Apple Hills Fruit Farm, 131 Brooks Road, Binghamton, NY 13905

From the North: Take exit # 7 (Castle Creek) from I 81. Turn right and take Rt. 11 South for 1 mile. Turn right on Brooks Rd. (Route 105) and go 2.6 miles.

From the South: Take exit # 6 from I 81. Turn right on Rt. 11 and go .5 mile. Turn left at light by Lowes and go 1.4 miles, still on Rt. 11. Turn left on West Chenango Rd. (Rt. 104) and go 2.7 miles. Turn right on Brooks Rd. (Rt. 105) and go .3 mile. From the East or West: Take Rt. 17 to I 81 North, then follow directions for "From the South".

From the East Via I 88: Take exit #2 (Chenango Bridge). Turn right on Rt. 12A West and go .9 mile. Turn left on Rt. 12 South at light and go .5 mile. Turn right on Rt. 11 North at light by Lowes and go 1.4 miles. Turn left on West Chenango Road (Rt. 104) and go 2.7 miles. Turn right on Brooks Rd. (Rt. 105) and go .3 mile.
