



RAIN, RAIN, RAIN, ICE! Pretty much sums up the weather conditions since my October Newsletter Article. The logging industry here in the Northeast, experienced five months of mud season. It seriously hurt all Loggers and Sawmills. One Logger told me he went from producing two loads of logs per day, to two loads per month, from August through all of December. Another told me he would build an Ark, if only he could get enough logs out of the woods to make the lumber!

The wet weather persisted into early January. Then, one night, someone pushed the freeze button! As soon as the temperature dropped into the 20's, the frost went in quick and deep. The water-

logged ground turned hard, and Loggers went joyfully back to work. Many on the brink of financial ruin, even braved the negative temperatures, just to get logs **out** and cash flow **in**. The low log production for five months, hurt Loggers and sawmills, but helped stabilize prices. According to "Joe", prices are down from last winter's high, but overall, they are not bad. Demand is strong, and all species and grades are selling. Let's hope the cold spell hangs around for a good while longer.

Hudson River Hardwood Exports' Log Yard Tour

Normally, in October, our log yard is bustling, as it gears up for the new shipping season. However, this year was different. As mentioned in the April Newsletter, Export shipments to China were halted, due to tariffs and enforcement of Chinese regulations on the fumigation and debarking of logs.

Our inventory of logs was intentionally reduced throughout the summer, into early fall, in order to see how the trade deal would be worked out between China and the U.S.



Although inventory was low, our Log Yard Tour went ahead as planned. This year, we went one step further in educating the attendees on the production process of logs to lumber, by having on hand some samples of finished wood products, such as flooring, ax handles, cabinet doors, and baseball bats. In doing so, we were able to show which logs produced which products and why.



As always, our attendees were satisfied with the education and information they received, by our expert Jason Post.

Spotted Lanternfly Monthly Update to Stakeholders PLEASE DISTRIBUTE TO YOUR ORGANIZATIONAL MEMBERSHIP AND STAFF

Background: The NYS Department of Environmental Conservation (DEC), NYS Department of Agriculture & Markets (DAM), the US Department of Agriculture Animal and Plant Health Inspection Service (USDA-APHIS) and the NYS Office of Parks, Recreation and Historic Preservation (OPRHP) have coordinated a multi-agency effort to prevent, detect, and respond to the threat of spotted lanternfly (SLF). First discovered in Pennsylvania in 2014, SLF established populations have since been confirmed in Virginia, New Jersey, and Delaware. To date, no SLF established populations have been confirmed in New York, although a few individual insects have been found in the state. A Unified Incident Command System (ICS) was established in January 2018 to leverage the joint effort and organize resources and responsibilities. Since then, plans and activities have been implemented, largely focused on early detection and prevention. Raising general awareness is particularly important, with an understanding that public reporting is powerful and effective with such a unique looking pest.

Updates:

- In September, both Albany and Yates counties had confirmed reports of a single live adult SLF. Dead insects have also been found in Delaware, Broome, and Monroe counties. Follow-up surveys did not detect established populations associated with these finds.
- As of January 2018, an established population of SLF has not been detected. To date, over 1901 km² grids have been surveyed for SLF in high priority areas.
- SLF established populations have been confirmed in the following states: Pennsylvania, Delaware, Virginia, and New Jersey.
- In New York State, DAM issued an exterior quarantine that restricts the movement of certain goods brought into New York from New Jersey and Pennsylvania, and counties with confirmed infestations in Delaware, and Virginia. - In Pennsylvania, the following counties are under quarantine: Berks, Bucks, Carbon, Chester,
 Delaware, Lancaster, Lebanon, Lehigh, Monroe, Montgomery, Northampton, Philadelphia and
 Schuylkill. For more information, please visit <u>Pennsylvania Department of Agriculture website</u>.
- In New Jersey, the following counties are under quarantine: Warren, Hunterdon and Mercer. For more information, please visit the State of New Jersey Department of Agriculture website.
- On Tuesday, January 22nd, 2019, members of the NYS ICS met and conducted a "hot wash" in Albany, NY. At the meeting, ICS members reviewed the successes and challenges of 2018 in hopes of improving the system in 2019.
