Annual Meeting

This year the meeting will be held **before the July 17 Rembold Woods Walk**. The purpose is to hold the annual election of officers for the Allegheny Foothills Chapter of NYFOA. Woods Walk—McCarty Hill State Forest, Town of Little Valley, NY —August 14th

Dan Shaffer will be hosting a Woods Walk August 14th at the McCarty Hill State Forest in Little Valley. Dan will be sharing the State Forest management planning including timber sales and recreation; reviewing past sales in the area of Mutton Hollow road and CCC Cross Public Forest Access road; and comparing harvested stands and treatments with unharvested stands. All of these are in close proximity with each other. We will look at regeneration in each stand and discuss limiting factors and management decisions of each site.

The area is relatively flat ground and the walk between stands amounts to crossing old logging roads. More details will follow as we get closer to the woods walk
