## **USDA Conservation Stewardship Program (CSP)**

NYFOA members all work closely with our properties, from timber stand improvement and sustainable timber harvest to wildlife management and invasive vegetation and erosion control. USDA's CSP program offers many programs in these areas that can help with your costs and could even return one to several thousand dollars to you each year, while improving your forest. Below are some of the forest related programs you may want to consider.

In addition to these forestry programs there are others programs in each category which relate to pasture, range and crop activities if you engage in those.

The best way to find out what makes sense for you is to contact the USDA agent for your county.

"CSP is a way of incentivizing farmers, ranchers, and private forest managers who maintain a high level of conservation on their land and agree to adopt higher levels of stewardship," said Gregory A. Kist of USDA's Natural Resources Conservation Service. "By focusing on multiple resource concerns, landowners are able to achieve a sustainable landscape and maintain or increase the productivity of their operations."

"Applications should be submitted to local NRCS offices. As part of the CSP application process, applicants will work with NRCS field personnel to complete a resource inventory of their land, which will help determine the conservation performance for existing and new conservation activities. The applicant's conservation performance will be used to determine eligibility, ranking and payment"


